### **OVERVIEW OF THE H-1B ELECTRONIC REGISTRATION PROCESS**

In December 2019, U.S. Citizenship and Immigration Services (USCIS) announced the implementation of the electronic registration process for the H-1B cap with a \$10 registration fee per individual entered in the lottery.

### **Create USCIS account**



Employers seeking to sponsor an individual in the H-1B cap must create a USCIS online account at: **myaccount.uscis.gov/users/sign\_up**.

The USCIS online account system uses a two-step verification method: Authentication App (such as Authy or Google Authenticator), SMS Text Message, or Email.

Two-Step Verification Method
Every time you log in, you will be given a verification code. What is your preferred method to receive your verification code?
Use an Authentication App Retrieve codes from an authentication app (such as Authy or Google Authenticator) on your mobile device.
<ul> <li>SMS Text Message Receive a text message to your mobile device when signing in.</li> </ul>
Email Receive an Email when signing in.
You can use most Time-Based, One-Time Password (TOTP) applications for added security, which will ask you to enter a unique verification code generated by the selected application on your mobile device.
USCIS advises that you read the privacy policies of any application you use, especially if you share any personal information. USCIS is not responsible for the information collection practices of non-USCIS applications.

The information entered should be for the signatory for the G-28 for the registration. When selecting the account type, please choose **"I am an H-1B Registrant."** Do not select Petitioner account.

In order to complete the registration, the following information is required:

#### **COMPANY INFORMATION:**

• Legal name of the company, including any doing business as name(s), if applicable

- Federal employer identification number (FEIN) of the company
- O Primary U.S. headquarter office address of the company
- Legal name, title, and contact information (daytime phone number and email address) of the authorized signatory

#### H-1B BENEFICIARY INFORMATION:

- Full legal name
- Gender
- O Date of birth
- Degree
- O Country of birth
- Country of citizenship
- O Passport number

### **3** Company reviews registrations and G-28



Once the attorney has completed the registrations, he/she will provide the company with a one-time passcode that will be needed to access the registrations for review. The company representative will need to login to the account created in Step 1, and again select **"I am an H-1B registrant."** 

• Upon logging in, the company representative will be directed to a page that gives options. Please select **"Enter representative passcode."** It will be a white button on the right.

## A REGISTRANT'S USCIS ONLINE ACCOUNT WILL SHOW ONE OF THE FOUR FOLLOWING STATUSES FOR EACH REGISTRATION:

- Submitted: A registration status may continue to show "Submitted" after the initial selection process has been completed. "Submitted" registrations will remain in consideration for selection until the end of the fiscal year, at which point all registration statuses will be Selected, Not Selected or Denied.
- Selected: Selected to file an FY 2021 H-1B cap-subject petition.
- $\Rightarrow$  **Not Selected:** Not selected for this fiscal year.
  - Please note that a registration will not reflect a status of **Not Selected** until the conclusion of the fiscal year. In the event that USCIS determines that it needs to increase the number of registrations projected to meet the H-1B regular cap or the advanced degree exemption allocation, USCIS will select from registrations held in reserve to meet the H-1B regular cap or advanced degree exemption allocation.
- ▷ Denied: The same registrant or representative submitted more than one registration on the beneficiary's behalf for the same fiscal year. All registrations the registrant or representative submitted on behalf of the same beneficiary for the same fiscal year are invalid.
